  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this Privacy Policy.

## Scope of this Privacy Policy

3. This Privacy Policy applies only to the actions of Moorlake Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
4. For purposes of the applicable Data Protection Laws, Moorlake Ltd is the "data controller". This means that Moorlake Ltd determines the purposes for which, and the manner in which, your Data is processed.

## Data Collected

5. We may collect the following Data, which includes personal Data, from you:

in each case, in accordance with this Privacy Policy.

## How We Collect Data

6. We collect Data in the following ways:
  - a. data is given to us by you;
  - b. data is received from other sources; and
  - c. data is collected automatically.

## Data That is Given to Us by You

7. Moorlake Ltd will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - b. when you use our services;

## **Data That is Collected Automatically**

9. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
  - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

## **Our Use of Data**

## Data Retention

## Your Rights

20. You have the following rights in relation to your Data:

  - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** - the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
  - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
  - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
